## LIMITED TO FOUR (4) MARKET BEEF PER EXHIBITOR

**COMPETITION REQUIREMENTS:** (subject to change without notice)

- 1. All entrants must have read and be familiar with the Colorado State Fair General Competition Requirements, General Livestock Competition Requirements, Junior Livestock Competition Requirements, Junior Livestock Sale Participation Requirements and Health Requirements. Exhibitors must comply with the Wholesome Meat provisions.
- 2. All exhibitors in Open, Junior Breeding and Market shows must submit a Premises ID (PID) number at the time of entry. PID may be obtained online on the Colorado Department of Agriculture website.
- 3. **BEDDING:** Exhibitors are responsible for their own livestock bedding. Entry into competition at the Colorado State Fair and Industrial Exposition does not include bedding. Bedding may be pre-purchased at the time of entry. Pre-purchased bedding may be picked up in the designated area on load-in days. Exhibitors must be present to claim their pre-purchased bedding. Refunds will not be issued for any pre-purchased bedding.

Straw may only be used for Dairy Cattle, Dairy Goats, Breeding Sheep and Cattle tie-outs. All other uses of straw are prohibited.

Outside bedding for livestock exhibitors is permitted.

- 4. BARN SECURITY/RESTRICTED AREA: For security reasons, all Market Hog, Market Lambs, Market Goat and Market Beef barns will be locked at 9:00 p.m. every night prior to sale date, and remain locked until 6:00 a.m. the following morning. Each barn will have Colorado State Fair Public Safety Officers to secure the area and to enforce the nightly lock down. Exhibitors must confine their animals within their designated stall or pen assignment and wash rack not to wander in general public areas.
- 5. Market Beef Classes are open to steers and heifers. Steers and heifers must weigh a minimum of **1,050** pounds to be eligible to compete in the market classes.
- 6. All heifers must be accompanied by a certificate issued by a licensed veterinarian verifying the heifer is pregnancy tested OPEN within 30 days of Colorado State Fair.
- 7. No steer or heifer born before January of the previous year is eligible to show. The dentition process may determine age. All animals must have both temporary central incisors (baby teeth) in place. Any evidence of tampering with tooth development will be cause for disqualification. The dentitions' decision is final.

- 8 Steers and heifers will be shown by weight. Steers and heifers will be divided by sex into classes as determined appropriate by the Colorado State Fair Superintendents. Heifers will compete in a heifer class. All steers placing first in a class will compete in the Grand Champion Drive. Second place class winner from the class from which the Grand Champion Market Beef is selected may be considered for Reserve Grand Champion Market Beef. Heifers will compete equally with the steers in the Grand Champion Drive.
- 9 ENTRY NUMBERS: Each entry will be assigned a number. Entry numbers will be provided to exhibitors. These numbers must be displayed by the exhibitor when the animal is in the show ring.
- 10 There will be no official weigh-in of Market Beef. Scales will be available for the exhibitors' use until the deadline for turning in the weight nomination form. An official weight nomination form must be obtained by the Exhibitor when the animal is inspected. The official weight nomination form must be turned into the Livestock Office no later than the deadline listed above. The weight(s) indicated on the weight nomination form will be the official show weight. There will be no changing of weights or breeds after the weight nomination form has been turned in.
- 11 A water container, with water, must be visible and available for watering on a regular basis in each penned/stalled area at all times. <u>NO</u> feeding or watering of livestock in show rings, holding pens or to and from re-weigh stations will be permitted. Colorado State Fair Officials reserve the right, at its discretion, to contact a CSF veterinarian to determine if water should be given. **Drenching for hydration purposes will be allowed. No stomach pumping will be permitted.**
- 12 Nose rings or tongs may be used by market beef exhibitors for the control of their animal.
- 13 Exhibitors <u>only</u> are allowed in the beef show ring staging areas.
- 14 Any violation of the following Competition Requirements regarding fitting of livestock will result in automatic disqualification with no recourse:
  - (a) The natural color of the steer/heifer cannot be altered using any artificial coloring. However, products that match the natural color of the steer/heifer may be used in the fitting process from the knees and hocks down and on the switch only. (For example, black products may be used on black-legged steer/heifer, red on a redlegged steer/heifer, and white on a white-legged steer/heifer.
  - (b) Any grooming material on any other part of the body not mentioned will be rubbed with a cloth or glove which will show evidence of artificial color.
  - (c) Any entries adding an artificial tail head or tail fin, artificial poll, or any hair or hair-like substance.
  - (d) The showing of livestock of any ineligible age or showing unethically fitted livestock is prohibited.
  - (e) Unethical fitting will be deemed to consist of any method, which alters the natural conformation of any part of the animal's body.
  - (f) Any ear tag tampering or removals, other than by a Colorado State Fair official or licensed veterinarian.
- 15 After each class of Market Beef has been placed, the top five animals will be weighed on the official scale by show officials. Market Beef cannot deviate more than 5% above or below the declared show weight as previously designated by the exhibitor on the weight card. If any Market Beef is weighed out, it will be disqualified and the remaining animals will be moved up in placing. The disqualified beef is not eligible for any other class and will not be reweighed.
- 16 Once the sale beef have been determined, those animals will be moved to a showcase area designated by the Livestock Superintendents. All equipment, except for those items needed to feed and water animals and clean stalls, shall be removed from the barn. The Colorado State Fair will provide each exhibitor with two (2) bags of shavings for use in the new stalling area.
- 17 This show is a terminal show **only** for the Jr. Market Beef that are selected for the Junior Livestock Sale. There is no buy-back consignment offered through the Colorado State Fair. Jr. Market Beef that do not make sale will be released to the exhibitor after the final sale order is posted. Market Beef exhibitors are encouraged to utilize sound biosecurity practices upon departure from the Colorado State Fair; recommended biosecurity procedures are available in the Livestock Office.
