## **Entry Requirements**

These requirements are in addition to the 2024 Colorado State Fair General Competition Requirements, the General Entry & Fine Arts 2024 Competition and Entry Requirements, and the 2024 Exhibitor Code of Conduct.

- A. An entry consists of one or more items entered by one exhibitor or one FFA Group in a single class to be judged together. For example, in class 8, an individual entry may consist of multiple panels and gates entered by one exhibitor. The set will be judged as one entry and subject to a single entry fee.
- B. Judges will base placement on evidence of sound planning, the number and degree of skills involved, the practicality of the entry, and quality of workmanship. Judges reserve the right to move entries to a different class if they fit better.
- C. Only Colorado FFA members whose work and records are completed to date and who are certified Agriculture Education Teachers (CVATA) are eligible to exhibit in the FFA Group and FFA Youth groups. No entries will be accepted unless properly certified. Entries must be primarily constructed by the FFA member(s.
- D. Exhibitors, please enter through Gate #8.
- E. All articles entered for the exhibit must be placed before 6:00 p.m., Thursday, August 22nd.
- F. An FFA Group consists of two or more FFA members working together to create an entry.

  When entering, use the name of the FFA group as the exhibitor name.
- G. FFA Members entering in *FFA Group* or *FFA Youth* groups, may not also enter *Youth* or *Adult* groups.
