## Entry Requirements

These requirements are in addition to the 2026 Colorado State Fair General Competition Requirements, the General Entry and Fine Arts 2026 Competition and Entry Requirements, and the Colorado State Fair Exhibitor Code of Conduct.

1. Open to all ages
2. Entries must use King Arthur Flour and be made from scratch. No mixes.
3. Any type of scone is welcome. Present at least five servings.
4. This competition is for home bakers. No professional bakers are allowed.
5. Entries must be prepared at home and brought to the fairgrounds between 1:30 p.m. and 2:00 p.m. on the contest day. One gate pass per exhibitor will be left at Gate 2 (on Arroyo Ave.) for the exhibitor to bring in the entry. The pass will be at the gate (under the exhibitor's name) on the contest day.
6. Entry recipes must be typed on an 8 ½" x 11" sheet of paper. Do not put your name on the recipe. Submit three copies of the recipe with your entry form. Recipes should list ingredients with measurements and amounts. Recipes should include step-by-step preparation and baking instructions. Be specific.
7. All recipes become the property of King Arthur Flour Company and the Colorado State Fair Authority. By participating, the contestant agrees that King Arthur Flour and Colorado State Fair Authority may edit, adapt, copyright, publish, and use any or all recipes entered. They may also use contestant names and photos without compensation for publicity, promotion, or advertising.
8. Include the King Arthur Flour package, UPC, product label, or receipt with your entry.
9. Taxes are the responsibility of the winner. This contest is void where prohibited or otherwise regulated by law.

10. Employees of King Arthur Flour, its affiliates, subsidiaries, agencies, and their families are not eligible to enter.
