

## LIVESTOCK PASS, PARKING AND ADMISSION INFORMATION

- Special Gate and Parking Pass information for Livestock exhibitors! Passes may be purchased with Colorado State Fair Livestock entries. No passes will be mailed out to exhibitors. Exhibitors can pick up their passes in the Livestock Office when they arrive and check in. Exhibitors may also purchase passes at the time of check-in at the Colorado State Fair.
- All vehicles must enter through Gate 4. All vehicles must stop at the Vet Check-In for animal inspection and Health Paper verification. Exhibitors will be issued a 30-minute loading/unloading permit which will allow them onto the Fairgrounds to unload animals and pick up passes in the Livestock Office. Any vehicle abusing the 30-minute time limit may be towed at the owner's expense.
- After initial load-in, no vehicles may come onto the Fairgrounds until such time as they are ready to load out animals after showing.
- All-age Livestock Exhibitor Wristbands should be purchased for parents, grandparents, siblings, or friends of 4-H/FFA exhibitors unless they elect to purchase daily gate admission tickets. Beginning Friday, August 28th, everyone who walks through Gate 4 **MUST** have either a wristband or general admission ticket.
- Exhibitors staying in the campground area and walking to the Livestock area through Gates 5 ½ and 6 ½ **MUST** have either wristbands or daily passes. Failure to possess either of those items may result in you not being allowed onto the grounds.
- Daily tickets may be purchased at Gates #3 (Carnival Gate), #5 (Prairie Gate) and #9 (Beulah Gate) or online. The Colorado State Fair will be offering Special Discount Days – those will be posted at [coloradostatefair.com](http://coloradostatefair.com).

### Livestock Exhibitor Passes:

#### 4-H/FFA Livestock Exhibitor Wristband

(1 per exhibitor, must be entered in Livestock show) \$15.00

Livestock Exhibitor Wristband (all ages) \$45.00

Livestock Parking (outside gate 4) (good for all 11 days) \$45.00

- 4H/FFA Livestock Exhibitor Wristbands are for youth exhibitor showing livestock at the reduced fee of \$15.00 – 1 will be issued per exhibitor – additional 4H/FFA wristbands ordered under an exhibitor's name will be charged the \$45.00 for the all-age Livestock Exhibitor band. 4-H/FFA Exhibitors should not be purchased for siblings who may be in 4-H/FFA but not exhibiting livestock at the Colorado State Fair. Passes will not be released until any balance due is paid.
- All trailers must be parked at the designated off-premises parking location (free) located at 3302 Mirror Avenue, just off South Pueblo Boulevard. Trailer parking maps will be available at the Livestock Office when you check in. No trailers are allowed in the parking lot outside Gate 4 or in the South Lot. No sleeping or animals allowed in trailers in the trailer lot.
- All vehicles parked outside Gate 4 must park within lines. All vehicles parked in the South Lot must be parked in an orderly fashion.
- Gate 4 parking passes do not allow for parking in the official lot behind the Livestock Pavilion, behind the Sheep and Swine Barn or behind the Goat Barn. Overflow parking for Exhibitor Gate 4 parking will be in the South Lot.
- Vehicles not parked in the correct parking space or lot areas may be towed at the owner's expense. No exceptions! Vehicles not possessing the correct or expired permits will be towed at the owner's expense. No exceptions.
